### **UTTC Institutional Governance Group Definitions**

## **UTTC Committee**

- Groups of persons appointed or selected to perform and function on behalf of a larger group
- Typically headed by a committee chair, have by-laws, keep records of minutes, and may have a budget
- Standing Committee enduring, no fixed end-point
- Sub-Committee a part of a committee that is organized for a certain purpose, reports to the committee
- Ad Hoc Committee a defined change and deadline after which the committee will cease to exist
- Primary purpose is to consider and recommend actions and propose policies in the functional areas.

## **UTTC Task Force**

A temporary group of people formed to carry out a specific mission or project, group dissolves when the mission or project is completed, created on an "as needed" basis.
